Reading

KS2 progress Guidance

A sentence for key stage 2 progress has not been triggered because the criteria have not been met.

Attainment (all key stages) Guidance

- Sentences for key stage 2 reading attainment of the expected and high standard have not been triggered because the criteria have not been met.
- Sentences for key stage 1 reading attainment of the expected standard and greater depth have not been triggered because the criteria have not been met.
- The proportion of pupils who met the expected standard (32+) in phonics in Year 1 (92%) was significantly **above** national and in the **highest** 20% of all schools in 2019 as well as 2018 and 2017.
- A sentence for early years foundation stage attainment of the expected standard in the reading early learning goal in 2019 has not been triggered because the criteria have not been met.

Writing

KS2 progress Guidance

• Key stage 2 progress in writing (2.4) was significantly **above** national and in the **highest** 20% of all schools in 2019.

Attainment (all key stages) Guidance

Key stage 2 attainment of the expected standard in writing (93%) was significantly above national and in the highest 20% of all schools in 2019 as well as in 2018 and 2017. A sentence for key stage 2 writing attainment of greater depth has not been triggered because the criteria have not been met.



- Sentences for key stage 1 writing attainment of the expected standard and greater depth have not been triggered because the criteria have not been met.
- A sentence for early years foundation stage attainment of the expected standard in the writing early learning goal in 2019 has not been triggered because the criteria have not been met.

Mathematics

KS2 progress Guidance

- Key stage 2 progress in mathematics (2.6) was significantly **above** national and in the **highest** 20% of all schools in 2019 as well as in 2018.
- Mathematics progress has improved between 2017 and 2018.

Attainment (all key stages) Guidance

- A sentence for key stage 2 mathematics attainment of the expected standard has not been triggered because the criteria have not been met. Key stage 2 attainment of the high standard (110+) in mathematics (44%) was significantly above national and in the highest 20% of all schools in 2019 as well as in 2018.
- The three-year average mathematics attainment score (107.4) was in the **highest** 20%.
- Sentences for key stage 1 mathematics attainment of the expected standard and greater depth have not been triggered because the criteria have not been met.
- A sentence for early years foundation stage attainment of the expected standard in the mathematics early learning goal in 2019 has not been triggered because the criteria have not been met.

Other measures in 2019 Guidance

- A sentence for the percentage of pupils in 2019 achieving the key stage 2 expected/high standard in reading, writing and mathematics has not been triggered because the criteria have not been met.
- In 2019, 97% of pupils achieved the expected standard (100+) in the key stage 2 English grammar, punctuation and spelling test, significantly **above** national and in the **highest** 20% of all schools. In 2019, 53% of pupils achieved the high standard (110+) in the key stage 2 English grammar, punctuation and spelling test, significantly **above** national and in the **highest** 20% of all schools.
- In 2019, 98% of pupils achieved the key stage 2 science expected standard, significantly **above** national and in the **highest** 20% of all schools.
- A sentence for the percentage achieving a good level of development in the early years foundation stage in 2019 has not been triggered because the criteria have not been met.

Absence (whole school) Guidance

- A sentence for overall absence has not been triggered because the criteria have not been met.
- A sentence for persistent absence has not been triggered because the criteria have not been met.
- Sentences for overall and persistent absence compared with schools with a similar level of deprivation have not been triggered because the criteria have not been met.

- There were no permanent exclusions in 2017/18. The national average for this year was close to zero. There were no permanent exclusions in the previous two years either.

Pupil groups Guidance

- For middle prior attainers, Key stage 1 attainment of the expected standard in mathematics (71%) was significantly **below** national in 2019.
- For high prior attainers, key stage 2 progress in reading for high prior attainers was significantly **above** national and in the **highest** 20% of all schools in 2019.
- Overall absence for pupils with special educational needs (3.2%) was in the **lowest** 20% of all schools in 2019.

MAT/LA level information Guidance

School workforce Guidance

According to the November 2018 school workforce census:

- in 2017/18, 56.5% of teachers had at least one period of sickness absence compared with a national average of 54%.
- in 2017/18, 2.4 days on average were lost to teacher sickness absence compared with a national average of 4.0.
- at the time of the census, there were no full-time vacant teacher posts in the school.

Local area Guidance

- The school location deprivation indicator was in quintile 3 (average) of all schools.
- The pupil base is in quintile 1 (least deprived) of all schools in terms of deprivation.

Finance Guidance

- In 2017/18, the academy trust had a revenue reserve of £675,000.
- In 2017/18, this school had a negative in-year balance (£-49,426), the second year in a row in which expenditure has exceeded income.
- In 2017/18, this school had a per pupil spend of £4,185.
- In 2017/18, this school received £1,772,000 in grant funding, £406,256 more than the national average.


